This library-sponsored program aims to engage parents, volunteers, service providers, school counselors and other professionals to recognize & address literacy-related reading issues.

Margaret went over selected reading material for three specific age groups: birth to two-year olds, two & three year olds, and four & five-year old children. At all levels, research shows that children who have larger vocabularies tend to be better readers. The knowledge of many words helps children recognize written words and understand what they read.

### Narrative Skills

Being able to describe things & events and tell stories.

### Phonological Awareness

Being able to hear and play with the smaller sounds in words.

### Vocabulary

Knowing the name of things.

### Print Awareness

Noticing print, knowing how to handle a book and knowing how to follow the words on a page.

### Print Motivation

Being interested in and enjoying books.

### Letter Knowledge

Knowing letters are different from each other, knowing their names & sounds and recognizing letters everywhere.

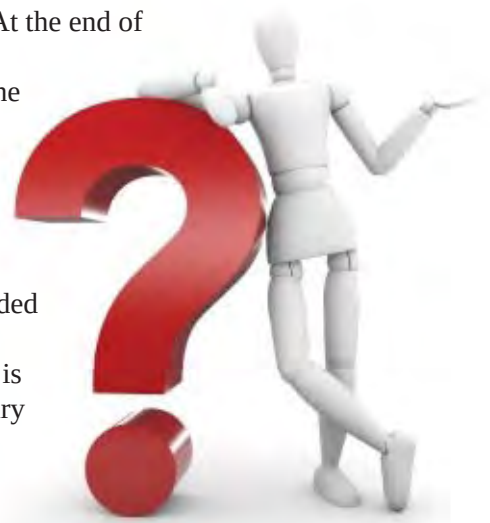
# VOLUNTEER EVALUATIONS

As we all begin a new year, we strive to look back on the year we've completed. At the end of 2009, we sent out approximately 100 guardian/foster parent evaluations. About one-third of the evaluations received have been processed by our office. With all the data we received, we will be assessing our strengths and weaknesses, after which we hammer a plan of action into place to improve our program for those whose lives we touch in the community.

Our survey results showed that the areas of concern are that our CASA volunteers need to make more contact with the family and that CASA's also need to be reminded of their boundaries in their court-assigned role. As a result of this survey, we are requesting that your CASA child be seen one time or more per month if needed. It is essential that CASA's establish a rapport and build a relationship that is so necessary in the work of advocacy and speaking up for a child's best interests. Also, the CASA office will be offering further training in boundary issues to assure that we are not overstepping the boundaries set forth in our initial training.

Vigo County CASA did receive excellent ratings in other parts of our survey. We would like to quote some of our feedback. "Out of all the people involved with my children, the CASA volunteer they like the most." "I really think that the Vigo County CASA program was a godsend to us."

If there are problems occurring, please don't hesitate to contact the CASA office at 812-231-5658. Often times we are not aware of the problems that are occurring. As soon as we know these issues they will be addressed immediately to ensure the child is being represented in the best way possible! Surveys are one of the ways we will be able to improve our program. Thanks to all who participated and returned their surveys.



## CASA<sup>TM</sup> KIDS CORNER

As the year ends and new one begins, CASA Kids reflects back and plans ahead. In 2009, we accomplished many good things for children thanks to the kind and generous donations from community businesses, volunteers and personal donations.

As a direct result of these gifts, we were able to provide bunk-beds and mattresses, build a fence to allow children to play safely at their home, provide gas cards, buy clothes and winter coats, fill cosmetic orthodontia needs, purchase eye contact lenses and more. It is the mission of CASA Kids to provide goods and services to children in need who aren't able to receive these goods or services from any other source.

Our CASA volunteers know that these children need and deserve more than just the bare necessities. To develop positive self esteem and strengthen the courage to try new things, children need enrichment opportunities and activities. Too often children in the juvenile court system are denied these opportunities simply because there are no funds to cover the additional expenses.

As we get into the swing of 2010 we have several exciting fundraisers started and planned. To launch the year, we began the Elder-Beerman Community Day Sale. We sold \$5.00 coupon booklets that could be used for deep discounts and bonus buys at Elder-Beerman on specific days in February. One-hundred percent of the proceeds have gone directly to CASA Kids.



We are also planning a "Breakfast with the Easter Bunny" at a local restaurant and a silent auction / barbeque in early summer. Details are still in the works and will be published when they are confirmed.

Cans for CASA Kids has raised more than \$200 by recycling aluminum cans this past year despite the decrease in prices for metals. Not bad for something that would have been just thrown away. We would like to make 2010 our best year yet. To recycle cans for CASA Kids, please drop your cans at Goodman & Wolfe, Gurman Containers or Sugar Creek Scrap in Terre Haute. Let them know you would like to donate the proceeds to CASA.

We also accept cans at the CASA office. Our goal for 2010 is to collect 1000 lbs of aluminum cans, and you can help us reach it. This year, we have already received over \$50 from our Cans for CASA Kids aluminum recycling campaign!

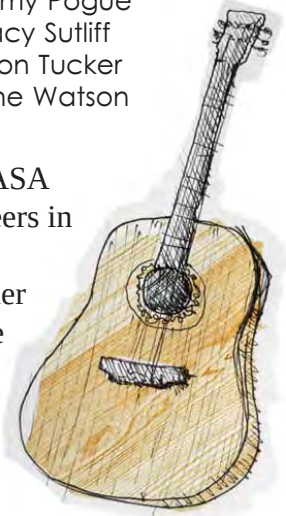
