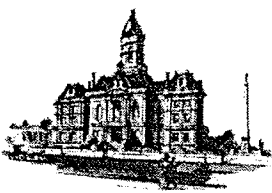

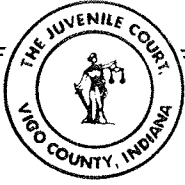

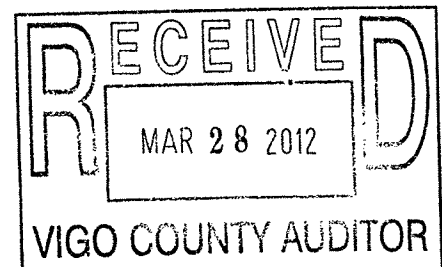
Greetings,

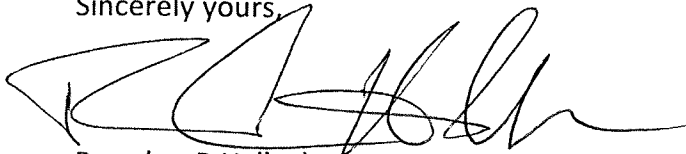

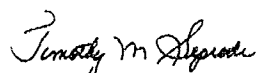
