Minutes 6/25/13. County Auditor Tim Seprodi presented the Board with the minutes of the Commissioners Meeting on 6/25/13.

Expenditures. County Auditor Tim Seprodi presented the Board with expenditures for 6/22/13-6/30/13 in the amount of \$1,886,194.41.

Election Board / Election Sites. Vigo County Clerk Dave Crockett informed the Commissioners the Election Board has designated election sites, but has not been approved yet.

Town of Riley / Vigo Co. Building Inspection/Interlocal Agreement. The Board of Commissioners was presented with an Interlocal Cooperation Agreement with the Town of Riley for the purpose of providing inspection services to the Town through the Vigo County Building Inspection Department to assist the Town in enforcing its ordinances. Dale Sowards commented Seelyville & West Terre Haute has own enforcement entities in place, Riley does not. County would do same process as normal but on behalf of Riley. Commissioner Brad Anderson asked if the Town could fine the violators, Mike Wright stated yes, according to provisions of their ordinance the costs will be born by the Town and hold Vigo County harmless. This does not bind the county to assist them to clean up. Commissioner Judith Anderson has concerns of Dale being spread too thin. Mike commented all ordinance violations are set on same day in courts, the first Friday of each month. Commissioner Ciolli asked if the county was taking on the grass violations also, Dale Sowards stated they were not. Commissioner Judith Anderson asked about liens on property and then tax write off in tax sale, can county make a policy they must pay half. Mike Wright stated that is only for Certificate Sale and county can collect by including in Minimum bid.

Motion made to approve Interlocal Agreement with Riley.

Restricted Access Statute. Discussion was had regarding the Restricted Address Access Statute that took effect July 1, 2013. The Auditor will create a suppression list and apply to Beacon. This will be done by request only, and is for law enforcement, judges, prosecutors, correctional officers; current and former; and domestic violence victims. This will apply to their home only and not other property. General access websites only apply, tax records are still available. Mike Wright will bring back information next week for signature.

Abstractors Access to Tax. Commissioner Brad Anderson asked about the fee to Abstractors to access MVP remotely. Kylissa Miller stated IT has not billed and IT says they are waiting on Mike Wright, Mike commented they do not need anything from him, he will contact IT.

Vote Centers. Kim Norris from the Taxpayers Association provided a list of questions the members have regarding vote centers. She commented the responses can be emailed. Dave Crockett stated he would like to set up a time to go over questions; email is not a good method for this situation.

There being no further business, it is now ordered the Board be recessed.
