The office will be open from 8 AM to 4 PM Monday through Friday. Open two Saturdays prior to election day, April 25th and May 2nd, 10 AM TO 6 PM. The deadline to vote In-Person is Monday, May 4th at noon. You do not have to give a reason, the only qualification to vote In-Person in the courthouse is that you are registered for this Primary.
