IMPORTANT NOTICE:

In accordance with the Election Reform Act in Indiana any registered voter may vote in the Clerk's In-Person Voting Office prior to election day. In-Person Voting begins Tuesday, October 6th. The office will be open Monday through Friday 8 AM to 4 PM. Open two Saturdays prior to election day, October 24th and October 31st, 10 AM to 6 PM. The deadline to vote In-Person is Monday, November 2nd at 12 noon. You do not have to give a reason, the only qualification to vote In-Person in the courthouse is that you are registered to vote in this Municipal General.
