

## **Food Inspections**

**Grand Café, 2309 S 3<sup>rd</sup> St (4 Critical, 5 Non-Critical)** Fryer, sauce bottles found with accumulated food debris; Meatloaf, gyro meat, cooked corn and soups in walk-in cooler not date marked; Cooked corn on the cob found in brown water in cooler; Dirty rags found in handwash sink. Establishment closed by Health Department, follow up inspection scheduled for 3pm.

**Real Hacienda, 3728 Wabash Ave (2 Critical, 3 Non-Critical)** Cooked rice in steam table found at 129 degrees – should be at least 135; Observed raw meats stored above ready to eat foods in several coolers.

**Savoia's Pizza and Subs, 727 Wabash Ave (2 Critical)** No proof of Certified Food Handler; Ground beef and cooked pasta not date marked.

**Kroger J-987 & Fuel Center, 4714 S US Hwy 41 (1 Critical, 5 Non-Critical)** Mac and cheese, mashed potatoes, potato wedges, fried chicken, baked chicken and chicken tenders in deli hot case found at 116-128 degrees – should be at least 135.

**Stables Steakhouse, 939 Poplar St (1 Critical, 2 Non-Critical)** Inside ice machine found with pink and black debris.

**Rick's Smokehouse & Grill II, 4200 S 7<sup>th</sup> St (1 Critical, 2 Non-Critical)** Vacuum packed raw beef stored over packaged butter and macaroni and cheese (corrected).
