Panera Bread Bakery/Café #1088, 5653 S US Hwy 41 **(2 Critical, 1 Non-Critical)** Bread pans, perforated sheet pans, and sheet pans found with burnt on debris and grease; Soda nozzles in lobby found with black debris.
