Bruce Allen requests a copy of new roads so he may prepare to update the county road map.

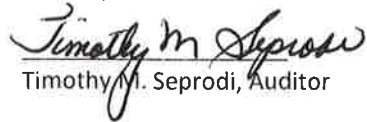
County Auditor Tim Seprodi stated that himself, Cheryl Loudermilk and Tona Bean will be gone until Friday at a conference out of town.

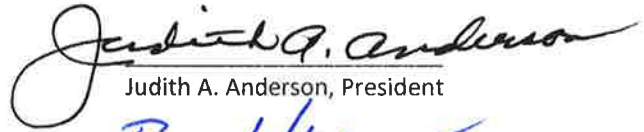

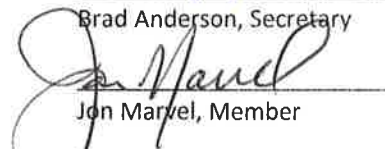
