China Garden, 1353 Wabash Ave., **(2 Critical, 2 Non Critical)**-Eggrolls, breaded chicken, and raw beef all found at 54-73F, should be 41F or less; Par cooked broccoli found at 73F, should be at least 135F.

West Vigo IGA, 1000 W National Ave., **(2 Critical, 1 Non Critical)**-Fried chicken, macaroni and cheese, and mashed potatoes found in warmer at 117-129F, should be at least 135F; Dividers in 3 bay sink no longer connected on bottom allowing sanitizer solution to seep into rinse water.

Chili's Grill and Bar, 5601 S US Hwy 41, **(2 Critical, 1 Non Critical)**-Debris observed on soda nozzles in wait station; Hand wash sinks found dirty.

Grand Traverse Pie Co., 75 N 3rd St., **(2 Critical)**-Certification provided is not an accredited test; No sanitizer dispensing in automatic dishwasher.

Park Avenue Diner, 2697 E Park Ave., **(2 Critical)**-Certified food manager certificate found expired; Employee assembling sandwiches with bare hands.

Ruby Tuesday's #7673, 3451 S US Hwy 41, **(2 Critical)**-Hot water in dishwasher found at 147-156F, shall be 160F to properly sanitize; Half sheet pans used for baking potatoes and plastic sheet pans found no longer cleanable.

Moon Dawg Lounge, 408 W National Ave., **(1 Critical, 2 Non Critical)**-Debris found on soda fountain nozzle.

Fazoli's Restaurant #1659, 2940 S 3rd St. **(1 Critical, 2 Non Critical)**-Fettuccine and spaghetti noodles found at 48-50F in line cooler.

Long John Silver's #34, 2021 Wabash Ave., **(1 Critical)**-Drive thru and lobby soda nozzles found with built up black debris.

Pizza Hut dba Vigo County Pizza Hut, 3040 Wabash Ave., **(1 Critical)**-Accumulated debris observed inside ice machine.

Tolly's Bar and Grill, 2341 Maple Ave., **(1 Critical)**-Food certification provided not an accredited test.

Texas Roadhouse, 201 E Turner, **(1 Critical)**-Hot water in mechanical dishwasher found at 156F, shall be 160F to sanitize. Chlorine sanitizer measured 10ppm in bar dishwasher.
