At 10:30 A.M. the Board held Rezoning Meeting.

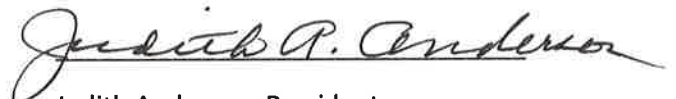

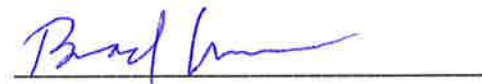
