

VIGO COUNTY, INDIANA BOARD OF COMMISSIONERS

**A RESOLUTION ASSIGNING TAX SALE CERTIFICATES
TO MENTAL HEALTH AMERICA OF WEST CENTRAL INDIANA, INC.**

WHEREAS, Vigo County, Indiana, by and through its Board of Commissioners, is the holder of tax sale certificates on the properties described in **Exhibit A** attached hereto;

WHEREAS, pursuant to IC 6-1.1-24-17, the Vigo County Board of Commissioners may assign tax sale certificates held in the name of the county executive to a nonprofit entity, subject to the right of redemption and the terms and conditions described in IC 6-1.1-24-17(f);

WHEREAS, pursuant to IC 6-1.1-24-17(d), the Vigo County Board of Commissioners has provided public notice of the hearing to consider the assignment of the tax sale certificates for the properties described in **Exhibit A** to Mental Health America of West Central Indiana, Inc., an Indiana nonprofit organization (the “Assignee”);

WHEREAS, the Vigo County Board of Commissioners has conducted a public hearing regarding the proposed assignment; and

WHEREAS, no meritorious objections or opposition has been presented regarding the proposed assignment to Assignee.

NOW, THEREFORE, **BE IT RESOLVED** BY THE VIGO COUNTY, INDIANA BOARD OF COMMISSIONERS:

1. That Vigo County, Indiana by and through its Board of Commissioners hereby makes a final determination and approves the assignment of the tax sale certificates for the properties described in **Exhibit A** hereto to Assignee.
2. That the Vigo County, Indiana Board of Commissioners specifically assigns and confers its rights to the removal of certain property taxes and special assessments described in IC 6-1.1-25-4(e) to Assignee, with respect to the issuance of tax deeds to Assignee for the properties described in **Exhibit A** hereto.
3. That the period of redemption for the properties described herein shall be one hundred twenty (120) days after the date the foregoing tax sale certificates are assigned, pursuant to IC 6-1.1-24-17(f).
