

INTERLOCAL COOPERATION AGREEMENT

THIS AGREEMENT made and entered into this 7th day of October, 2019, by and between the **BOARD OF COMMISSIONERS OF VIGO COUNTY, INDIANA** (hereinafter "County"), located at 121 Oak Street, Terre Haute, IN 47807 and the **TOWN COUNCIL OF THE TOWN OF RILEY** (hereinafter "Town"), P.O. Box 501, Riley, IN 47871.

WHEREAS, a power that may be exercised by a political subdivision and by one or more other governmental entities may be exercised by one or more entities on behalf of others; and

WHEREAS, the County and the Town desire to enter into this Interlocal Cooperation Agreement pursuant to I.C. 36-1-7, et seq, for the purpose of providing inspection services to the Town through the Vigo County Building Inspection Department to assist the Town in enforcing its ordinances; and

WHEREAS, the County has agreed to allow the Vigo County Building Inspector to periodically inspect properties located in the Town for possible violation of the Town's municipal ordinances; and

WHEREAS, the Town understands and agrees that any costs incurred for enforcing its municipal ordinances will be borne by the Town and the Town will hold the County harmless from any liability therefore; and

WHEREAS, the parties involved in this Agreement are political subdivisions of the State of Indiana; and

WHEREAS, the Board of Commissioners of Vigo County and the Town Council for the Town have approved, by ordinance or resolution, the Agreement being entered into herein.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, the Board of Commissioners of Vigo County and the Town Council for the Town, hereby enter into the following Interlocal Cooperation Agreement:

I. **Duration of Agreement:** The term or duration of this Agreement shall be in perpetuity until notice is given pursuant to Section IV.

II. **Purpose of Agreement:** This Agreement was created for the purpose of providing inspection services to the Town by the County on a periodic, as needed, basis to assist in ordinance enforcement for the Town's municipal ordinances.

III. **Manner of Staffing:** It is anticipated that the Vigo County Building Inspector, and/or his deputies, shall provide inspection services to the Town on an as needed basis to inspect various properties throughout the Town for possible violation of the Town's municipal ordinances.

IV. **Methods for Termination:** Either party may terminate this Agreement at any time upon providing written notice thereof to the other party.
