Re: House Manager Stipend Request

Dear President Ellis and Members of the Council,

I respectfully request consideration of an amendment to the 2026 Salary Ordinance to include a stipend for the House Manager positions at the group homes.

During the 2026 budget process, I asked the Council to consider approving a modest annual stipend for this role. Over the past year, it has become increasingly clear that an intermediary supervisory position is necessary to support operational needs previously managed by the Operations Director. Additionally, with the reopening of the Carpenter Home, staff increased from six to twelve employees, effectively doubling the supervisory span of control. Best practices indicate that an optimal supervisory ratio is approximately five employees, with a general range of three to seven.

In response to these operational demands, we worked with Human Resources to establish a "working supervisor" role to assist with oversight and daily operations of the group homes. This position continues to perform all Youth Care Specialist duties while also assuming additional supervisory responsibilities as outlined in the job description.

Given these added responsibilities, I believe it is appropriate to provide additional compensation. Accordingly, I am requesting approval of an annual stipend of \$2,000 for each of the two House Manager positions, for a total fiscal impact of \$4,000 per year from the General Fund. The stipend would be distributed in two equal payments, one in June and one in December.

We are making meaningful progress at VCHC, and I believe this adjustment will enhance operational efficiency and strengthen our ability to serve the children in our care.

After consulting with Jordynne Gackle, Human Resources Director, I am offering the following language and request the Council amend the 2026 Salary Ordinance.

All full time Youth Care Specialist holding the current title of House Manager, are eligible to receive a stipend of \$2,000 to assist in the day-to-day management and oversight of the individual group home locations. To be eligible for this stipend an employee must have continuous services as a House Manager for 6 months prior to receiving the stipend. Equal installments of the stipend will be paid in June and December.

This language matches the language currently used in the 2026 Salary Ordinance.

Dear President Ellis and Council Members:

I respectfully request to be placed on the agenda for the April 2026 meeting of the Vigo County Council to discuss an additional appropriation from the Group Homes Non-Reverting Fund (#4962). Specifically, I am requesting an appropriation in the amount of \$46,500.00 to be allocated to the following line item:

#33300 – Contractual Services: \$46,500.00

These funds will be used to purchase and install two (2) furnaces at the Glenn Home. The home is currently heated by a boiler system that circulates water to radiator units throughout the building. During periods of extreme cold, the boiler has been unable to maintain adequate indoor temperatures. The Indiana Department of Child Services requires a minimum indoor temperature of 62 degrees Fahrenheit for facilities housing youth. On two separate occasions this winter, we were required to temporarily relocate residents to an alternate site due to insufficient heating.

After consulting with multiple contractors and the Maintenance Director, we have identified the most effective solution given the structural characteristics of the building. The proposed plan includes installing one furnace in the third-floor attic space, with ductwork extending to serve the second floor, and a second furnace in the basement boiler room, with ductwork serving the first floor. This approach minimizes visible ductwork and preserves the general character of the home.

In addition to resolving the heating concerns, this upgrade would allow for the installation of central air conditioning, replacing the six (6) window units currently in use. This improvement is expected to enhance overall efficiency and potentially reduce cooling costs.

This appropriation would be funded through the Group Homes Non-Reverting Fund, which consists of payments received from the Department of Child Services and does not involve property tax revenue. As of the date of this letter, the fund balance is \$189,404.89.

I am requesting to be placed on the Vigo County Council agenda for the April Meeting to discuss an additional Appropriation of funds from the Vigo County Homes for Children Non-Reverting Fund #4952. I am requesting an appropriation of **\$45,000.00 to be placed in the following line item. It is:**

#44460 Vehicles for \$45,000.00

This appropriation is to purchase a transportation vehicle for the group homes. I would like to purchase a 12 passenger van. This van would be utilized to transport residents of the group homes for a number of reasons like, school, medical, treatment, special events, and visitation just to name a few.

The Vigo County Highway has been a big supporter of the Group Homes and has helped us keep out rolling stock operational. We would be moving our outdated 2016 Chrysler Voyager 180,000 miles out of our inventory and replacing it with this vehicle. The 2016 Chrysler would then be given to the Maintenance Department to help them provide services to the group homes.

Of course, this appropriation would come from our Non-Reverting Fund which is **NOT property tax** but payments from DCS. As of the date of this letter, **the fund balance is \$189,404.89.**

These fees are maintained in the Alternative Dispute Resolution Fund #2200 and currently has a balance of seventy-five thousand twenty-seven dollars and ten cents. (\$75,027.10).

This Alternative Dispute Resolution Fund #2200 can be used in family court for domestic relations cases for limited purposes and for those types of services as approved for use through the Indiana Office of Court Services.

It is impossible to predict in any given year, how much money will be expended from the Fund to ensure that families can obtain necessary services ordered by the Court. Accordingly, a request is being made to appropriate the entire Fund amount to ensure sufficient funds are available if and when necessary. The Alternative Dispute Resolution Fund #2200 belongs to the Court and cannot revert back to the general fund and each year a request will be made for the appropriation of the entire amount of the Fund for the benefit of families in need. Payments will be made directly to vendors providing services to the families.

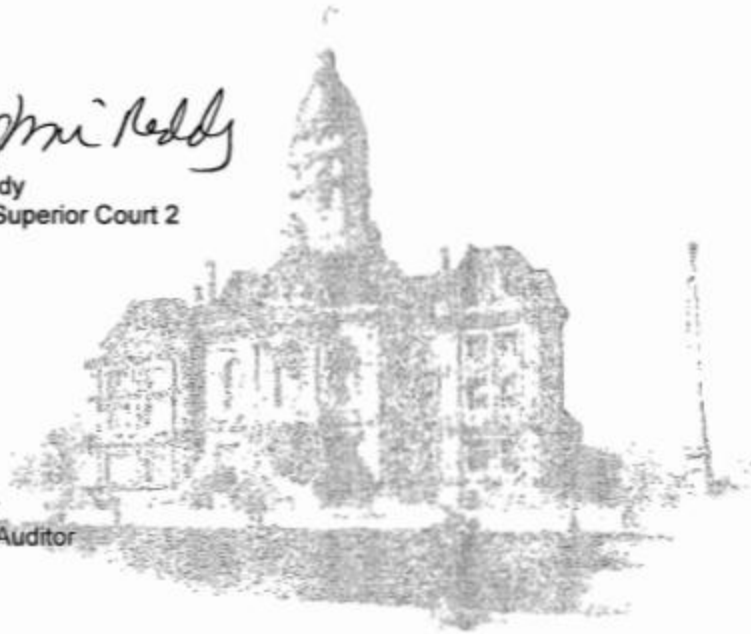

Council President Ellis and members of the Vigo County Council:

First, I apologize for any confusion related to this request made at the March 3rd, 2026 meeting. On behalf of the City of Terre Haute, the City respectfully requests approval of an appropriation in the amount of \$15,001 to assist with funding Warming Center operations in Vigo County for the 2025–26 season. This request was previously approved by the Council on December 29, 2025, as Additional Appropriation 2025-61, during a Special Session; however, the funds were neither expended nor encumbered.

In September 2025, the City convened a Warming Center Working Group to revise the current White Flag/Red Flag plan, which provides operational guidance and establishes parameters for opening and operating warming centers in Vigo County. Key objectives included broader—but more clearly defined—opening criteria and more consistent, aligned communications.

This effort has included representation and input from multiple City and County departments, as well as community stakeholders, and has resulted in the current Warming Center Operations Agreement with Mental Health America. To date, the Warming Center has operated for 34 days under this agreement. A copy of the agreement is attached to this request.

The City appreciates the County's continued partnership and support as we work to provide this critical service to our most vulnerable residents. The City will come before the Council later this year to provide relevant updates regarding Warming Center operations and related coordination efforts.

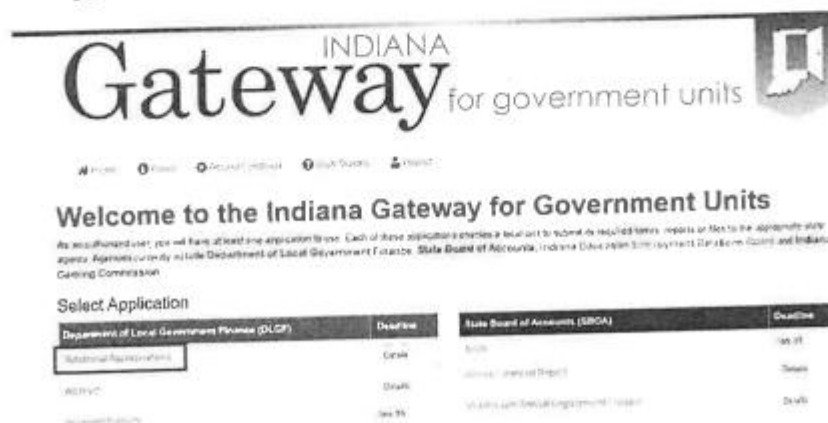
